BGA, Inc. Earns 'Supplier Performance Award'

WHITE PLAINS, NY, Jun 02, 2009 (MARKETWIRE via COMTEX) -- BGA, Inc., a subsidiary of ConEdison Solutions -- one of the country's leading energy services companies, has earned a Supplier Excellence Award under the 2008 United States Postal Service (USPS) Supplier Performance Awards Program.

At the same time, the Postal Service designated ConEdison Solutions to serve facilities in New York, New Jersey, Puerto Rico and the U.S. Virgin Islands. ConEdison Solutions acquired BGA, Inc. in May 2007.

The presentation was made by the USPS at its 2008 Supplier Performance Awards Ceremony and Reception on Monday, May 11 at USPS headquarters in Washington, DC.
